



Fox Valley Technical College is required by the U.S. government to verify a student's demonstration of sufficient financial support for the student and any dependent(s). All international students must demonstrate financial proof that they have sufficient funds readily available to cover tuition and fees, living expenses, and health insurance for at least one year of study to get an immigration document from Fox Valley Technical College.

**All tuition/fee amounts and living expenses are ESTIMATES. Amounts typically increase each year. Expenses do not include tuition/fees for the optional summer term.**

Please submit this completed form together with copies of the supporting documentation. Students must submit electronic copies of official financial documents to qualify for a Form I-20. Financial documents must meet all of the requirements listed below:

- Be an official bank document
- Be written in English
- Contain an issuance date within the last 3 months
- List the account holder's full name
- Indicate the current balance and currency
- All funds must be liquid and immediately available for withdrawal

- Savings account
- Any type of term deposit account that matures before the start of the school year
- Funding award letters (government or scholarship letters, loans, etc)

Non-Accepted forms of funding:

- Bank letters that do not provide a current balance

- Trust funds
- Loan sanction letters
- Any type of term deposit that matures after the start of the school year
- F-1 student sponsoring another F-1 student
- Tax forms
