NOTE ITEMS:

The Aeronautics Program at Fox Valley Technical College operates based on a first-come, first served policy per the Wisconsin Technical College System.

- 0 The Aeronautics program is in high-demand and we see a high volume of interest; please plan accordingly.
- O To most efficiently serve the students in this high demand area, the program operates on a constant out/constant in model.
 - □ If your position is such that you are eligible to enroll in core courses for the next available start, but do not, you may bypass that spot. Please note that if you bypass a spot, you may need to meet with an academic advisor and flight instructor to discuss you interest in the program.
- 0 After successful completion of Phase I, students will be officially admitted to the college.
 - □ Attendance to a New Student Orientation session is mandatory. These are typically offered three times a year; please plan accordingly.
- O Once students are admitted to the college, successful completion of the tasks outlined within Phase II of this guide will be mandatory for the Aeronautics program and official FAA Part-141 enrollment. Failure to complete any of the necessary steps will result in delayed start or program withdrawal.

- Students are required to assess their finances and make arrangements to have payment available prior to the first day of flight courses. We encourage students to apply for Financial Aid (if necessary) and to review the previous year's academic planner for estimate course costs (*course fees are subject to change). Documentation Guidelines & Compliance:

The Aeronautics Program requires students to submit many documents that are required by Fox Valley Technical College, the Federal Aviation Administration and Transportation Security Administration. Please view the items below to see the submission requirements. Please ensure all of your documentation meets compliance standards. If documentation does not meet the following criteria, students will be asked to resubmit their items:

- Full-color
- No corners or wording have been cut off
- All information is current and legible

- Current U.S. Passport: scan image of current, signed and open passport
- Official Birth Certificate & Driver's License:
 i. Birth Certificate: scan image of full birth certificate (front only)
 ii. Driver's License: scan image of front & back of license; ensure all images are clear.
- Certificate of Naturalization & Driver's License:
 i. Certificate of Naturalization: scan image of full certificate of naturalization
 ii. Driver's License: scan image of front & back of license; ensure all images are clear.

- Confirm FAA Medical Certificate is signed & has been issued within the last 12 calendar months.

or the following: provide completion of an associate's or higher degree OR ; 165 or higher on your 2014 series GED tests OR ; 2.75+ high school GPA (within the last 10 years) OR ; ACT or SAT or Accuplacer or Companion or Compass (within the last three years) to waive to the general education level. Students need the following minimum scores OR Equivalent Program Prep Course(s):
Accuplacer Algebra Score 250 or ACT Math 18
Accuplacer Sentence Skills Score 250 or ACT English 18 Accuplacer Reading Score 250 or ACT Reading 18

Phase II – FAA Equipment Verification & Official Part 141 Enrollment (Once Admitted)

Objective: complete these requirements to be eligible to enroll into Fox Valley Technical College's FAA Part-141 Aeronautics Program. Students have the option to complete the tasks within Phase II at any point. Students will be sent a reminder communication from an FVTC staff member as to when they should begin their tasks. Students who do not successfully meet compliance will be ineligible to move forward. Please read all pertinent details below.

Please Note: students will receive a reminder email communication when they are within the Top 10 and Top 5 on the Flight Ready List.

FAA Equipment Verification
Purchase all items from the Required Resource List (this will be emailed to you after you successfully complete
Phase I and have earned a seat on the Core Ready List). Once all items are completed, request to complete an FAA Equipment Verification.
Please note that all items that are listed within the Resource List are required and approved by the FAA for official 141 enrollment – no substitutions.
