For Direct PLUS Loans first disbursed on or after July 1, 2023, and before July 1, 2024, the interest rate is 8.05%. This is a fixed interest rate for the life of the loan. A loan origination fee is assessed resulting in a lesser amount disbursed to the student's account. The current loan origination fee is 4.228%.
