

STEP 1 APPLY

Complete the online International Student Application - www.fvtc.edu/GlobalWelcome

(Completed applications will only be processed upon payment of the \$100.00 processing fee)

STEP 2 VERIFY FUNDS

1. Complete the **Official Certification of Source of Funds** form available at www.fvtc.edu/GlobalWelcome
2. Submit an **official** bank statement or notarized letter from a financial institution, translated in English, verifying funds of \$17,580.00 (U.S. dollars) are available to cover all educational and living expenses for one academic year. Currency **must** be shown in U.S. Dollars. Cost breakdown for one year:

STEP 3 PROVIDE DOCUMENTATION

1. Provide a copy of your current, non-expired passport.
2. Scan or mail **ALL** documents. Mail to the address below. Email scanned documents to: ISSO@fvtc.edu. An I-20 **will not be processed** without the \$100 processing fee payment. Fee can be paid online during the application process or mail a check or money order with your documents.

APPLICATION DEADLINES:
May 15th August start (Fall)
October 15th January or June start (Spring or Summer)

Include the following documents if applicable:

- **English Test Scores**
Minimum TOEFL (70) or IELTS (6). Test scores are NOT required if enrolling into our *Intensive English Program*.
- **High School Diploma**
Provide an official copy of a high school diploma or completion certificate; *translated into English*.
- **College Transcripts**
Transcripts from a non U.S. university / college must be provided with a U.S. credential evaluation report through either the Education Credential Evaluators (www.ece.org) or World Education Services (www.wes.org).
- **Current F-1 students studying in the U.S.A.** (F1 Student Transfer Form at www.fvtc.edu/GlobalWelcome)
All documents mentioned in **Step 2 AND**;
 - Copy of current, valid VISA
 - Copies of ALL issued I-20 forms
 - Official copy of college transcript
- **Dependents**
If you are planning on bringing dependents (spouse, children) an additional \$8,000 per dependent must be available and verified on financial documentations. Provide a copy of a current, non-expired passport for each dependent.
- **Sponsor**
Form **I-134, Affidavit of Support** is only required if another person(s) will be sponsoring you with financial support. One form per sponsor is required.

STEP 2 Schedule a visa Interview

Schedule your interview with the U.S. Embassy and present your I-20 and letters of support during your interview. (Your interviewer decides whether or not to grant you an F-1 Student Visa.)

As you prepare for your embassy visit, contact your regional EducationUSA advisor. To locate your nearest EducationUSA center visit www.educationusa.info.

After your Visa interview;

1. **Immediately** notify us of your **Visa results and your arrival date** via email at ISSO@fvtc.edu.
2. Contact us via email at ISSO@fvtc.edu **immediately** upon your arrival to Wisconsin.
3. Attend the mandatory one-week *International Student Campus and Community Orientation Course* on the Appleton Campus at 1825 N. Bluemound Drive, Appleton, Global Education and Services, Room #G130.

F-1 students may arrive NO MORE than 30 days before the program start date noted on the I-20/Acceptance Letter. You will be admitted to Fox Valley Technical College as a general undergraduate student until ALL remaining requirements are completed.

NOTE: Students registering or arriving late will have **limited course** selection and may need to enroll in courses unrelated to their intended field of study.

All international students MUST be enrolled in a minimum of 12 credits per semester to maintain F-1 status.
