



Declaration of Finances

All international students must demonstrate financial proof that they have sufficient funds readily available to cover tuition and fees, living expenses, and health insurance for at least one year of study to get an immigration document from Fox Valley Technical College.

All tuition/fee amounts and living expenses are ESTIMATES. Amounts typically increase each year. Expenses do not include tuition/fees for the optional summer term.

Please review the document requirements for each type of financial support carefully.

- 1. The verifying letter from bank must be dated within the last 3 months.
- 2. Financial support cannot be from any source of stocks, bonds, or retirement accounts.

How do you plan to pay for your tuition and expenses?

- > Personal Funds
 - A current financial statement, printed on letterhead and signed by a bank official, no older than 3 months. This can also be a bank statement that clearly indicates the bank name, account holder name, amount of money, type of currency and date the statement is from.
 - Completion of the Self Sponsor questions below.
- Family/Friend funds outside of the U.S.
 - Affidavit of Support for Non-US Sponsors
 - A current financial statement, printed on letterhead and signed by a bank official, no older than 3 months. This can also be a bank statement that clearly indicates the bank name, account holder name, amount of money, type of currency and date the statement is from.





- Family/Friend funds inside the U.S.
 - A completed Affidavit of Support for Non-US Sponsors
 - Bank statement must validate a current and average balance of \$5,000 over a three month period (plus \$2000 for each F-2 dependent). The bank statements must be form a current account and should include the financial sponsors' full name, account number and beginning and ending balance. Submit last three months of statements.
 - And one of the following:
 - Employment letter. A statement from an employer on company letterhead and signed by a supervisor that certifies the financial sponsor's name, date of hire, job title, and salary. The Employment letter cannot be older than six months from the date the student submits the Fox Valley Technical College application and all additional
- Government Agency or Company Scholarship
 - An official sponsorship letter designated for attendance at Fox Valley Technical College.
- If you will be staying somewhere where you will receive free room and board
 - A letter who you are staying with indicating the amount of support they will provide for you and the duration of time you will stay with them.
 - A supporting document such as a utility bill, copy of lease or ownership of residence, or other financial supporting document.
