# Welcome

Welcome to the high school articulation process for Fox Valley Technical College! In partnership with your school district, FVTC is happy to provide opportunities for your students to explore potential careers, save time and money on college credits and enter the workforce better prepared. This guide will walk you through some basic articulation options, teaching requirements and the initial course request process. Once an agreement is in place, faculty mentors and the K12 Partnerships team will be with you every step of the way, as you begin your journey as a member of the FVTC team!

#### How do I get started?

Select between the following two types of course articulation:

Advanced Standing (AS): a high school class that closely matches a technical college course, taught by the high school teacher, under an Advanced Standing agreement with the college. A student receives AS by successfully completing the high school class with a B or better grade, and then enrolls in an Associate Degree or Technical Diploma program at FVTC. Student self identifies and provides HS transcript to begin award of credit during Admissions process. Credit accepted only at FVTC.

<u>Dual Credit (DC)</u>: an <u>FVTC course</u> taught by the high school teacher who has been certified and trained by the college to teach their class, under a Dual Credit agreement with the college. A student receives DC by successfully completing the FVTC course with a **C** or better, and is then awarded credit on the college transcript. There is no charge to a K12 district, or student, for Advanced Standing or Dual Credit courses.

Each fall the K-12 Partnerships team works with districts to determine what areas of growth exist in their high school pathways, to plan for expansion within Dual Credit opportunities for the coming year. #### How do I submit an initial course request?

You will receive a confirmation email from the Office of K12 Partnerships, with your FVTC login information. This may take up to three business days. All new course requests or renewals are due to FVTC **by February 15** for the coming academic year.

#### Once I am certified by the college, what happens next?

Once certified by FVTC, you will have access to Dual Credit resources and tools through your instructor login credentials, including People Soft (FVTC's student management system), Blackboard (if needed), etc.

To support and guide you in your role as a Dual Credit teacher, FVTC will provide a faculty mentor from the program that is related to your course. Your mentor can answer initial questions about content, textbooks, grading, etc. and will also invite you to their annual Summer Summit training where you will have focused, staff development time with other high school teachers who are also teaching your course. Once you begin teaching, your mentor will be available for classroom visits, connections to their career field, technology standards discussions, etc. and be a great FVTC point of contact for your students.

#### **Articulation FAQ's**

As a Dual Credit teacher, you may have occasional questions about FVTC processes. The following FAQ's may help address some of the resources you are looking for, once your class begins. #### Q: How and when do I register my Dual Credit students?

A: You will register your students in the college student management system called **PeopleSoft**, within the first three weeks of class, to ensure that they have access to all FVTC content. FVTC provides a short registration how-to video to help you and your students, and daytime support through the college's Enrollment Services team, should you run into any challenges on registration day. Simply call **920-735-5645** and identify as a Dual Credit teacher.

#### Q: What grading scale do I use for my Dual Credit students?

A: FVTC programs vary in the required competencies, length and structure, so there is not one standard college grading scale. You will work closely with your program mentor to understand and implement the FVTC grading scale for the specific program related to your course. This grading policy takes precedence, and any late work, retakes, etc. must follow FVTC course syllabus. Grades must be submitted within 48 hours after the end of the last day of your class.

#### Q: How should my school identify the Dual Credit classes in our course catalog and high school transcript?

A: Please use the FVTC course title and description, so it is clear to students, parents and other educational institutions, should the credit be transferred. Be sure to coordinate with your Counseling team to ensure that a current list of DC classes are noted in your course catalog each year.

#### Q: What if one of my students needs accommodations while enrolled in a Dual Credit class?

A: FVTC will not provide modifications if those changes would substantially alter the essential elements of the course. It is possible that accommodations available to a student, in the high school setting will not be allowed in a college level course. College credits earned through Dual Credit enrollment become part of a student's college transcript and can be transferable to other colleges. For that reason, a course taken for college credit must maintain the integrity and fidelity of college level work. As soon as the possibility exists that a student with a disability may be enrolled in your DC class, please contact FVTC's Disability Services team (920-735-2569) to begin a preliminary discussion about the potential services a student may need.

#### Q: If I will need a long-term sub while teaching a Dual Credit class, what process needs to take place?

A: Contact the Office of K12 Partnerships as soon as you are aware of this situation to ensure that the substitute placement follows FVTC credentialing requirements for the course you are teaching. In addition, your faculty mentor will play a key role in working with the substitute to assure that course structure is maintained and that grading and assessment protocols are followed. Ultimate approval of any long-term substitute falls to the appropriate FVTC program Dean.

#### Q: How do I maintain my Dual Credit certification with FVTC, to continue teaching my class, from year-to-year?

A: Annually, you will submit a course renewal to the Office of K12 Partnerships, and attend the program Summer Summit. Should you move to a new district and wish to teach this same class, a new certification/course request process begins with that school.

#### Q: Can I develop a new course agreement after the school year has begun?

A: All agreements for the academic year are closed as of September 1<sup>st</sup> and K12 district contracts are processed.

#### **Articulation Course List**

The following list of courses outlines those that are approved by FVTC for high school articulation consideration, along with teacher qualifications, expectations and terms of engagement. Courses are fundamental and introductory in nature and are selected by each program team **as** appropriate for articulation purposes. Teacher qualifications and terms of engagement are determined course by course, by FVTC faculty, specific to meeting instructional area requirements. Teacher certification is defined by the Wisconsin Technical College System and is based on the secondary teacher's current license from the Wisconsin Department of Public Instruction.

# Technology Tips for High School Dual Credit Instructors

#### What is my user name (or User ID)?

- Your user name is a combination of the letters "ext" (stands for external) & eight characters of your last name.
- For example, John Van Handel might use: ext.vanhande for his user name.
- FVTC assigns your User Id after you have submitted a new Dual Credit course request.


#### What is my password? How do I set it?

Currently, you need to call the FVTC Helpdesk to set your password: 920-735-5644.

• We are working on future functionality to let you reset your own password via the web.

#### How do I find where to go for stuff for FVTC?

- Go to our main website: www.fvtc.edu.
- Click on the **Staff Login** link in the top right corner.
- Under that you'll see links for MyFVTC Account and for Blackboard.



#### What is MyFVTC Account?

- MyFVTC Account is mostly used by you to enter grades in our system.
- You can also check your class rosters to make sure your students are registered.
- You sign in with your user name and password (see above).

#### What is Blackboard?

- Blackboard is our online learning system, where class content is stored (not all classes have access).
- It is similar to PowerSchool or Infinite Campus which you may have at your district.
- You sign in with your user name and password (see above).

#### How do my students find their FVTC ID and reset their password?

- If your student does NOT know his/her student id or password:
  - Go to MyFVTC (www.fvtc.edu/myfvtcaccount)
  - Select "Forgot ID?" or "Forgot Password?" to use the account look-up and/or password reset tool.




