- are a U.S. citizen or an eligible noncitizen, and
- were born after December 31, 1959,
- are not currently on active duty in the armed forces.

**Choose and complete one of the following:**

- If you have recently registered with the Selective Service, please attach a copy of your Selective Service Registration card or submit a printed copy of your Online Registration Verification from <https://www.sss.gov/>
- If you served on active duty in the armed forces but did not register before turning 26, you are still eligible to receive financial aid funds. Attach a copy of your DD Form 214 (Certificate of Release or Discharge from Active Duty).
- If you are a non-citizen who first entered the United States after the age of 26, provide documentation of when you first entered the United States. (Most recent I94 - online at <https://i94.cbp.dhs.gov/>, or passport with date of entry stamp, or letter from USCIS, etc.)
- If you are over 26 years of age, you must write to Selective Service to get a Status Information Letter addressing your failure to register. Go to [www.sss.gov](http://www.sss.gov) website for address and additional instructions or contact the Selective Service Administration at 1-888-655-1825.

**You must submit to the FVTC Financial Aid Office:**

1. A copy of your Status Information Letter that you receive from Selective Service, **AND**
  2. A written statement signed by you with documentation stating why you did not register for selective service. Include information such as where you were living at the time, if you were incarcerated or institutionalized, and your citizenship status during that period, if applicable.
- I am a female and am not required to register with Selective Service.
