*****Financial aid funding will be based on required program credits enrolled in on the Census Date.**

REFUNDS: Refund checks/eRefunds are typically processed within 2-5 business days after funds are disbursed into the student account and all charges have been paid in full. **More than one refund may be sent due to disbursement timing.** Please go to your MyFVTC > Financial Account > eFAS link to set up direct deposit.

BOOKS: To use financial aid to purchase books, you must log into the campus bookstore, eCampus, through your MyFVTC account (Manage Classes > Buy Textbooks). If you have available aid to charge books against, you will see a "credit" in your eCampus account. Only **required** materials are allowed to be purchased using your financial aid. Students will receive an email from the bookstore notifying them if they are eligible to use their financial aid to purchase required materials.

Class fees and tuition are due 10 days prior to the start date of the class. Students are fully responsible for all tuition and fees. To avoid late fees and collection activities, students must pay fees by the due date (or have enough awarded aid to cover fees) or must officially drop classes according to the refund policy. Students are not automatically dropped from class by not attending and are responsible for applicable class fees. Students must initiate drop requests online or through Enrollment Services. Drop requests are not accepted through instructors.

Payment plans are available for students with a tuition balance of \$300 or more. A down payment and set up fee may be required at the time of payment plan enrollment. Enroll online via eFAS Financial Account Suite (link found in your MyFVTC account).

If you have enough awarded aid, you do not need to enroll in a payment plan or make payment.
